G Degenhardt talked to the board about tentative plans for the 50th anniversary of the Tractor Pull which includes all school reunion with a band, fireworks, display tent and more. Would like the street closed Thursday-Sun with tent over part of street by library bridge. Also felt electric box on Shelter II would need to be updated to accommodate extra power needed for these extra events.

Clerk had a request by an individual who wanted to know if she purchased a cemetery plot for the cremated remains of her sister and the family decided not to bury her here would the Village 'buy back' the plot. The Board said it would not but offered that she could sell it via local newspaper ads.
